# Why a global balanced solution should be the core of your portfolio

# Why Mackenzie Global Strategic Income Fund

Mackenzie Global Strategic Income Fund is designed with the objective of delivering two critical outcomes to investors: growth and income.

**Growth:** The equity team seeks out high-quality, dividend-paying companies from anywhere in the world. The fixed income team looks for opportunities in any global bond market and across the credit spectrum to provide income and returns, as well as to act as a counter-balance to equity market risk. The Fund's combination of equity and fixed income enables it to deliver strong returns within a reasonable level of risk.

**Income:** The Fund can help to meet your life's spending needs with a steady, reliable monthly income stream, paying a fixed rate of 5% or 8% annual distribution. The income received comes from a diversified mix of sources that include dividends, bond coupons and capital gains but may also include return of capital.<sup>1</sup>

You can gain peace of mind knowing that the core (or foundation) of your portfolio is designed to deliver the growth you need by reinvesting distributions. However, it's also able to provide cash flow when you need it to cover any expenses that might arise.

### How it works

Mackenzie Global Strategic Income Fund combines the expertise of two of Mackenzie's investment teams. The Mackenzie Global Equity and Income team manages the global equity allocation of the fund, while the Mackenzie Fixed Income Team manages the fixed income component.

The equity portion of the Fund includes 50 to 80 companies — many of which are high-quality, recognized global brands — which pay dividends. Companies are selected from different industries, which give you access to opportunities that are under-represented in Canada.


