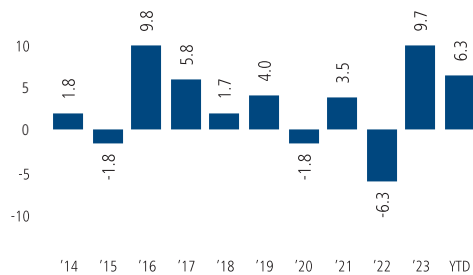

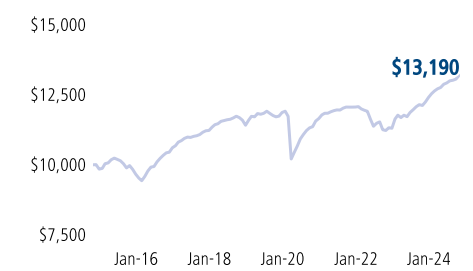

Why Invest in this fund?

- Floating rate loans offer higher yields than other short-term, fixed-rate assets.
